Licenses

Naturopathic Doctors are not licensed as primary care physicians in the state of Colorado. There are certain services that our doctors cannot provide, such as writing prescriptions and performing routine screening exams. Naturopathic medicine and Homeopathy are not a substitute for conventional medical care. It is recommended that you continue services with your primary care physician.

Experience and Training

All of the doctors at **Vitality Natural Medicine** hold N.D. degrees from the Southwest College of Naturopathic Medicine. Their training includes:

- Four years of post-graduate medical instruction
- Studies in basic sciences, conventional diagnosis, pharmacology, and natural therapies including homeopathy, botanicals, nutrition and hydrotherapy
- 1200 hours of clinical training
- Medical degree accredited by the Council on Naturopathic Medical Education (CNME) and The Higher Learning Commission of the North Central Association of Colleges and Schools.

Payment and fees

The doctors at **Vitality Natural Medicine** are not contracted with insurance providers. We do accept payment from Health Savings Accounts (HSA) and Flex Spending Accounts (FSA). Payment to **Vitality Natural Medicine** is expected at the time of service, via cash, check, or with credit card via Paypal.

Appointments can be changed or cancelled up to 48 hours before the scheduled time. Appointments changed or cancelled within 48 hours of the appointment time are subject to a cancellation fee matching the equivalent amount for the appointment.

You will be notified if there are any changes of services or charges.

Product Sales

Homeopathic medicines and nutritional supplements are available to purchase through **Vitality Natural Medicine**. This is a service that is available for your convenience. You are not required to purchase items recommended by your doctor from **Vitality Natural Medicine**. You are free to purchase these or similar products at the retailer of your choice.

Doctor- Patient Agreements

- I agree to give at least 48 hours notice (more is better) if I will not be able to keep my appointment, or I agree to pay the cancellation fee. _____
- I understand that Vitality Natural Medicine does not offer refunds.

- I understand that Dr. Quinn returns calls and emails within 48 hours Monday- Friday. Any calls or emails received after 12 pm Friday may be returned on the following Monday.
- For emergencies I will call 911 or my primary care physician.

Procedure for Refills on Patient Supplements

We do offer the best quality supplements to our patients from our practice. Of course, you will need refills along the way. Alternatively, you can send us the brand and product name listed on the product. We will be able to get the order shipped out to you right away once we have the information from you.

Most orders take 2 business days and will arrive Monday-Friday.

We do not recommend refilling vitamins through Amazon or other third-party retailers, as there have been many documented quality control issues. Since these are the medicines that we are relying on in your treatment, it is recommended to please refill all supplements with us. We want to guarantee that you are getting the best quality available from trusted and certified sources.
